..... Unpacking & claims

OBVIOUS DAMAGE, indicated on the exterior of the carton, and showing bad handling by a carrier enroute, should be noted on the receipt you signed on arrival. In this event, the proper agent for the delivering carrier should be contacted immediately if detailed examination does disclose damage to the equipment, and a joint inspection form completed with the carriers agent. The joint inspection form does NOT assign responsibility for damage, but is the basis for filing a claim if it is later determined necessary. If the shipment was by parcel post, contact your local postmaster for handling of claim forms.

HIDDEN DAMAGE may exist, even though the exterior of the shipping container shows not visible evidence of bad handling. If detailed examination discloses such hidden damage, the same procedure of a joint inspection report, or postal inspection, should be made.

Remember, responsibility for safe delivery rests with the carrier. The responsibility for instigating claims inspection and inspection rests with YOU. Prompt action on your part will speed adjustments. Our warranty in no way covers defects or damage due to bad handling in shipping. Under no circumstances should you return a shipment to your dealer or us before proper inspections and claims forms have been initiated; to do so may jeopardize your investment.

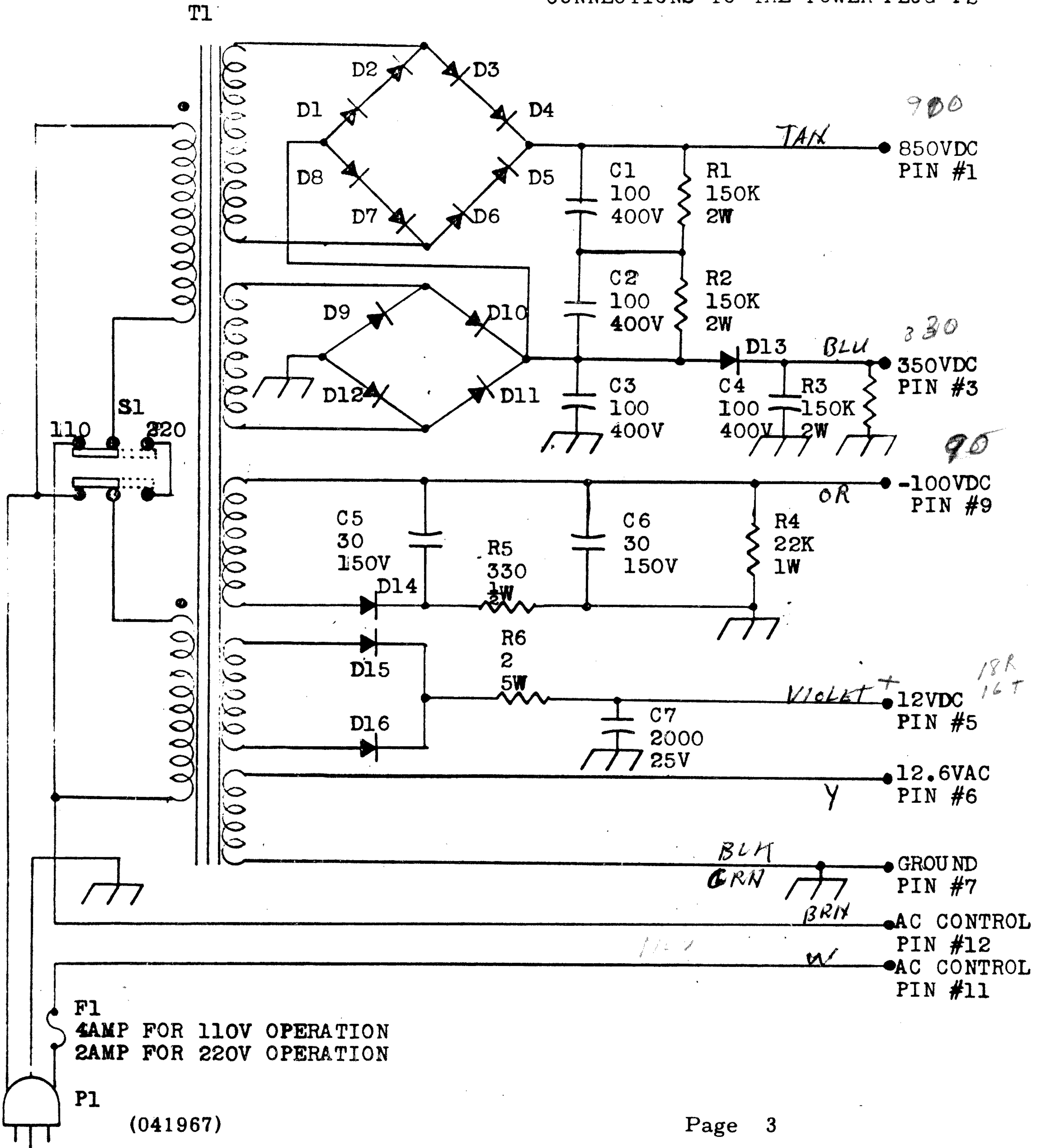
..... Installation

NOTE! This power supply is designed to operate from either 115VAC or 230 VAC, 50/60 CPS. IT IS SHIPPED WITH CONNECTIONS FOR 115VAC USE. You will notice there is a switch on the chassis to set the proper operating voltage. To change operating voltage, remove the polarizing plate (remove two nuts), move the slide switch to the opposite position, turn the plate over so it fits again, and install the nuts. The operating voltage in use is then visible on the polarizing plate. **DOUBLE CHECK YOUR SETTING !!!!!**

NOTE! When changing operating voltage, the proper fuse must be used. As supplied, for 115VAC use, an MDX4 fuse is installed. If the supply is changed for operation from 230VAC, a type MDX2 fuse **MUST** be installed. Do not use the 4 Ampere fuse even for a moment when operating from 230VAC.

Once the proper primary voltage is properly selected, and a good ground wire connected to the other equipment, then the secondary power cable from the supply may be connected. (The unit should be in the OFF position when the cable is connected.).

ORDERING PARTS---IN WARRANTY

Parts orders under \$5.00 must be accompanied by full remittance, plus adequate allowance for shipping(any overage will be refunded after shipment). Orders of \$5.00 or more can be shipped to you C. O. D. , providing 25% or more is included with your order. Be sure and specify parts clearly by symbol and our part number, or where this does not appear in the manual, by an adequate description, to avoid errors.

RETURNING EQUIPMENT FOR SERVICE

Do NOT ship equipment to us without prior authorization and proper return shipping labels, except where we may authorize shipment by phone without special shipping labels.

When shipping equipment, be SURE it is properly packed and fully insured. We assume no liability for incoming damaged equipment. Units received in damaged condition will be inspected for a damage estimate; you will be provided with a joint inspection form, as necessary, and the equipment will be held for your disposition. It can be returned 'as is', or repaired and returned for costs. You must file any claim for re-imbusement from a carrier for damages that occur enroute to us.

When returning a unit for service, a detailed letter should be sent to us indicating exactly what the trouble is, and what measurements or test you have made. This will enable us to provide the most through and fastest service.

ALL SHIPMENTS MUST BE PREPAID TO US.

WARRANTY

(Return may be waived at our option). Component parts in the A. C. 400, with the exception of fuses, are all guaranteed for one year, service labor for 90 days, from the date of purchase by the original owner.
